#### 22/05/02-01 Call to Order:

A quorum being present, Mayor Ken Bonokoski called the meeting to order at 6:00 p.m.

6:33 p.m. Bienfait Memorial Arena board members Amanda Pukas, Bill Mann and Jesse Juneau met with Council to discuss the insurance claim for the mechanical breakdown at the ice plant regarding the condenser.

Insurance will only approve 50% as the equipment was older than ten (10) years, therefore the approval was given on Actual Cash Value.

The Bienfait Memorial Arena is not in a financial position to cover the outstanding invoices on the repairs. The arena year end is August 31. In this year's fiscal income statement, the arena shows a revenue of \$104,163.99 and an expense of \$125,928.87. This does not include the Excel Refrigeration regarding the mechanical breakdown invoices of \$25,889.14 and \$16,098.28.

The Bienfait Memorial Arena plans on hosting more appetizer nights and other fundraisers.

The board members are hopeful to get ice plant upgrades purchased and installed during the 2022 summer months. This is expected to cost approximately one hundred eighty-five thousand (\$185,000.00) dollars plus taxes. A letter was prepared and distributed to both the R.M. of Coalfields No.4 and the R.M. of Estevan No. 5. A copy of this letter was presented to Bienfait Town Council.

Tundra Oil and Gas has donated one hundred thousand dollars (\$100,000.00) to go towards the purchase of new ice plant upgrades. This donation comes as a grant; therefore, the funds get released when invoices are presented.

- 4. The Town shall be responsible for cutting the grass as needed.
- All improvements made by the League shall become the property of the Town of Bienfait.
- 6. The Blue Jay Ball Diamonds shall forever remain the property of the Town of Bienfait.
- 7. The League shall agree to indemnify and hold harmless the Town of Bienfait from and against any claims, injuries, demands, liabilities, costs or damages related to the use, upgrading, or maintenance of the Blue Jay Ball Diamonds.
